This contract shall constitute a binding agreement between the Midwest Original Music Festival, (herein referred to as "Event Producer") and the undersigned Vendor(s).

1. Vendor understands that booth space allocation shall be at the discretion of the Event Producer.
2. Vendor must be open for business on all days of the event unless prior approval is given.
3. Vendor must open for sales by 11:00AM CST on all event dates and remain open for the entire event day.
4. Indemnification: Vendor hereby agrees to indemnify, and hold harmless the Event Producer, Event venue, the City of Franklin Wisconsin, and any of their assignees and contractors from and against any loss, liability, damage, injuries, or death.
5. Vendor understands that they are responsible for their assignees and property and in no way will the Event Producer be responsible for lost, stolen, or damaged property.
6. No refunds will be given for any reason including, but not limited to, Vendor no-show, acts of God, & any circumstances beyond Event Producer's control.
7. All applicable state and/or local sales taxes, permits, licenses, and/or inspection fees are the sole responsibility of the vendor.
8. Vendor understands that they, and their assignees, must conduct themselves in a professional manner at all times. Vendor understands that they will adhere to any and all venue and event rules and conduct their business activities within all local, state and federal laws. Croatian Park, Federation of Croatian Societies, Midwest Original Music Festival staff and their assignees reserve the right to refuse sales of items that are deemed to be distasteful, offensive, and unlawful and further reserve the right to end a vendor's and/or their assignee's participation in the Midwest Original Music Festival at any time.
